Encore! Mt. Morris, announces Art on Fire 2022, in memory this year of Dan Sheely long time Village of Mt. Morris employee. Interested artists (no residency requirements) will be permitted to "adopt" fire hydrants within the Village limits of Mt. Morris and paint creative, artistic designs. The goal of this program is to embrace local artistic talents while displaying creative artwork throughout the community. There is no specific theme, though artists are encouraged to incorporate the character of the surrounding environment and neighborhood into their artwork. Photos of each newly painted hydrant will be displayed online at EncoreMtMorris.com. The public will be asked to vote for their favorite new hydrant. There is no cost to apply for the program. Participating artists will receive an Encore 'Art on Fire' tee shirt. Artists are responsible for providing their own materials, brushes, etc. Prizes for 1st, 2nd & 3rd place.

Please note; existing hydrant artwork that is in good shape will not be painted over.

PROGRAM DETAILS

How can I participate in this program?

- _Fill out the application/design proposal (page 2 of this form).

- _Submit the required forms (by 8/8/22) to Mt. Morris Village Hall, 105 W. Lincoln St, Mt. Morris, IL 61054.
- _Encore! Mt. Morris will contact you once your application has been approved.
- Painting for 2022 will be allowed June 1st through August 14th, Awards announced 8/27 during StrawFest

How should I begin painting after receiving approval?

- Remove all dirt, loose paint, and debris and wipe down the hydrant with mineral spirits before painting.
- _Protect the immediate area around the hydrant from paint stains.
- The use of an oil-based primer before painting will allow paint to adhere to your hydrant better.
- Use Rustoleum, oil-based enamel paint for metal.

What is prohibited on the hydrants?

- The top cap color can not be changed; it is used for indication of water pressure.
- _Inappropriate words, advertisements, political messages, etc.
- Glued or attached objects.
- Camouflage or overly dark or light designs that significantly reduce hydrant visibility.

Once I have finished painting my hydrant, what should I do?


- _Sign the hydrant with your name.
